**A Bylaw to provide for the Naming of Streets and Avenues and the Re-naming of Existing Streets and Avenues Within the Boundaries of the City of Grand Forks**

**WHEREAS** under the provisions of the Local Government Act, the Council may, by bylaw, assign a name or number to a street or avenue or change the name or number of a street or avenue;

**NOW THEREFORE** the Council of the Corporation of the City of Grand Forks, in open meeting assembled, **ENACTS**, as follows:


1. That this bylaw may be cited for all purposes as the "City of Grand Forks Street and Avenue Naming Bylaw, No. 1738, 2003"
2. Bylaw No. 1154, "City of Grand Forks Street and Avenue Altering and Re-naming Bylaw No. 1154, 1982 is repealed.
3. That the attached Schedule "A" being a revised street naming map for the City of Grand Forks be hereby adopted. Schedule "B", attached represents the current street names.
4. This Bylaw and attached schedules be filed with the Registrar of Titles at the Kamloops Land Titles Office in accordance with the Local Government Act;



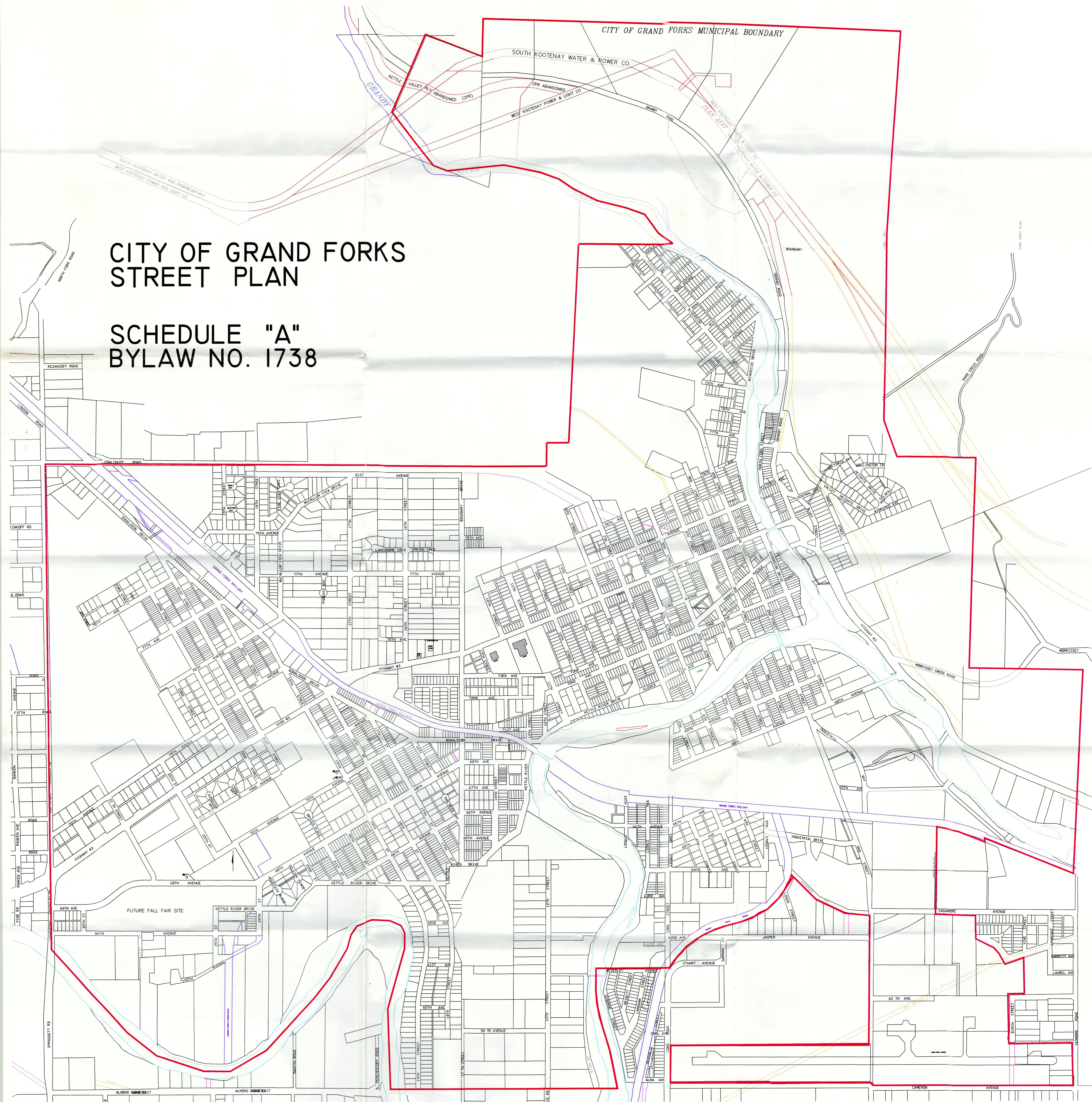
