FEES AND CHARGES AMENDMENT BYLAW NO. 1958-A16

A bylaw to amend the City of Grand Forks Fees and Charges Bylaw No. 1958.

The Municipal Council for the Corporation of the City of Grand Forks, in open meeting lawfully assembled, **ENACTS** as follows:

Citation

1. This bylaw may be cited as the **“Fees and Charges Amendment Bylaw No. 1958-A16”**

Definitions

2. In this bylaw, unless the context otherwise requires:
 - 2.1. **“Fees and Charges Bylaw”** means the City of Grand Forks Fees and Charges Bylaw No. 1958 as amended from time to time.

Amendment

3. The “Fees and Charges Bylaw” shall be amended as follows:
 - 3.1. Adding under Section 3.1 “Schedule N – Community Support Programs Fees and Charges”.
 - 3.2. Adding “Schedule N – Community Support Programs Fees and Charges” as identified in Appendix 1 of this Amendment Bylaw.

General

4. Any enactment referred to herein is a reference to an enactment of British Columbia regulations thereto, as amended, revised, consolidated, or replaced from time to time.
5. If any section, paragraph, or phrase of this bylaw is for any reason held to be invalid by a decision of Court of competent jurisdiction, such decision will not affect the validity of the remaining portions of this bylaw.

Read a first, second, and third time by the Municipal Council this 6th day of May, 2024.

COMMUNITY SUPPORT PROGRAMS FEES AND CHARGES**

Bench or Picnic Table	At cost*
Bench or Picnic Table – replacement**	At cost*
Bronze Plaque (with purchase of bench)	At cost*
Bronze Replacement Plaque	At cost*
Magline Plaque (for older style benches with Corian Plaques)	At cost*
New Back slat (second cutout plaque)	At cost*
Tree	At cost*
Freight – if required	At cost*
Labour/Equipment, includes, but is not limited to:	At cost*
- tree installation	
- bench/picnic table installation or replacement	

* the "At cost" rate will include all applicable taxes

** if not feasible to be repaired

The *City* will require a deposit for the estimated cost to purchase and install any item, with the understanding that should the actual cost exceed the deposit, the *Applicant(s)* will be required to pay the actual cost. If the actual cost is less than the deposit, the *Applicant(s)* will receive a refund of the balance of the deposit.

Any fee that is not specified above, and that may be required and that would fall under the Community Support Programs Policy will be charged "at cost".
