The BOUNDARY MUSEUM is much more than a Museum that can be visited at the beautiful Fructova Heritage Site.

Did you know the following things about the Boundary Museum?

We are responsible for or support the following:

## FRUCTOVA HERITAGE SITE & COMMUNITY ARTIFACTS

- The majority of the Community artifacts are stored at the Boundary Museum, a large portion of which are on display.
- The Boundary Museum Society is responsible for the storage, care and upkeep of the Community's artifact collection.
- The Boundary Museum is currently open 7 months a year and by appointment the balance of the year.
- The Boundary Museum Society pays \$1/year for the lease from the USCC. The Museum pays for utilities, insurance, care of the grounds, underground sprinkler system, a security system and fire system.
- With the receipt of grant funding, the Boundary Museum Society was able to undertake upgrades and improvements to the site including landscaping, new heat pumps, new window coverings that help protect the artifacts from dangerous ultra-violet rays, complete sanding and painting of the exterior and interior of the main building, a new 20' x 40' shade house, and an addition to the oven house. A large portion of grant funds received came through the generosity of Area D Director Perepolkin.
- Use of the grounds and new shade house is offered at NO CHARGE to residents and groups of the Boundary Country which encompasses Eholt to the Paulson Bridge.
- We are equipped with enough tables, chairs, dishes and cutiery. to serve 100
- In 2011, we hired 3 local students for summer employment through grants from Young Canada Works & Service Canada and seasonal employment for two employees.
- We act as ambassadors to the City of Grand Forks and Boundary Area welcoming people from all over the world.
- This past year we hosted and educated classes from our local schools as well as the Okanagan in such things as Doukhobor and 1st Nations culture. We were very pleased to host a school class from the Okanagan Immersion School near Vernon BC. They were a group of 40 people - 27 student, the rest teachers & parents. The School is called nkmapiqs I snmamaytn ki sqiixwtet which translates into the "Head of the Lake place of learning for our native ways". Their language is called nxilxcin and is also spoken by several of the tribes belonging to Colville Confederated Tribes in Washington state, including the Lakes. The tour was for the educational enhancement of their children as well to reconnect them with their ancestral lands.

- We provided one-on-one classes every Tuesday for local disabled youth. During this time they experienced things such as working with clay, beading, painting & more. It was great to see them come out of their shell and the rest of the staff enjoyed their laughter and giggles.
- We hosted several events including a City Council Meeting, a Credit Union staff function, a Rotary Club social, the Boundary Historical Society annual luncheon, and the Red Hat Ladies BBQ.
- Visitors are invited to leave their recreational vehicles at the Boundary Museum site during the day so that they may tour other venues such as our downtown businesses, the community archives, the Flour Mill, the Doukhobor Museum, and Gallery 2.

## **COMMUNITY ARCHIVAL COLLECTION**

Because it was important to the previous Council to have the community archival collections located in the City proper, the new archival location is located on the lower level of Grand Forks City Hall. The Boundary Museum Society's Board of Directors Is grateful to the City of Grand Forks for preparing a safe, secure and pleasant work space.

The Boundary Museum Society is responsible for the care and restoration of the community archives that includes several collections such as photos, maps, and documents. We are just getting settled in but eventually we will be able to offer the following services to the community:

- Scan original photos &/or documents for sharing and safekeeping
- Help to organize and protect photos, negatives & other valuable documents
- Help with research inquiries
- Provide and collect audio recordings of local history
- We will serve as a drop off for items community members may wish to donate or store at the new archival facility.
- We will accept donations of photos &/or documents related to the Boundary Area or residents past or present that live(d) in the Boundary area.
- We will take orders for photo reproductions

The archives will be staffed with one part-time person at 24 hours per week year round.

#### GYRO PARK

- Responsible for maintenance of the display buildings.
- Responsible for the cost of restoration of the artifacts on display.
  - In 2010, the Burns Wagon was completely restored.
  - The Bossburg stagecoach is currently under restoration at the Boundary Woodworker Guild's workshop.
  - All maintenance and restoration costs come directly from the Museum's operating budget.

## **HERITAGE FLOUR MILL**

- Set up of displays
- Help to sell flour on Fridays
- Provide support with Heritage tours

## HARDY MOUNTAIN DOUKHOBOR VILLAGE

- Lend volunteer labour and summer student support.
- The Boundary Museum holds and restores artifacts that will be used to appoint the building once finished.

## GRANBY WILDERNESS SOCIETY & SADDLE LAKE RESTORATION

- The Boundary Museum provides office space at the Fructova Heritage Site at no charge to the Granby Wilderness Society
- The Boundary Museum, Granby Wilderness and RDKB "D" are working in partnership in establishing the Saddle Lake Reservoir as a Regional Park.

#### **BOUNDARY WOODWORKER'S GUILD**

As a result of arrangements made between Area D Director, Irene Perepoikin, the City of Grand Forks and The Boundary Museum Society, the former SPCA building was leased to the Boundary Museum Society to use as a restoration workshop and storage area. The Boundary Museum came to an agreement with the Boundary Woodworker's Guild allowing them to use that space providing they did restoration work for the Museum. The Boundary Museum pays for materials for restoration projects and the labour is provided at no-cost. The Boundary Museum also offered space to the Spinner's & Weavers and the Quilters groups.
