"City of Grand Forks" receives Federal Gas Tax Fund contribution for "Performance Measurement and Reporting Framework for Sustainable Service Delivery"

February 12, 2016. Grand Forks, BC

The Federal Government announced today which communities will be receiving grants through the Gas Tax Strategic Priorities Fund (SPF). The City is receiving a grant in the amount of \$195,000 which covers %100 of the project cost.

Asset Management has been a Council priority since 2010. Asset Management is a practice that looks at the financial, assets and levels of service within an organization and then generates a long term plan to help get an organization on track financially over the long term, all the while putting dollars away that will eventually be needed to replace assets (i.e. infrastructure).

This funding is for the development of the framework providing a practical dashboard for charting the correct course through changing conditions. The framework provides confidence to staff, Council and the community that the City will deliver quality services today and long into the future.

Quick Facts

- The Grand Forks Performance Measurement and Reporting Framework for Sustainable Service Delivery is receiving \$195,000 from the federal Gas Tax Fund.
- The total estimated cost of this project is \$195,000.
- This project is one of the 57 projects that are being funded through the Strategic Priorities Fund under the Federal Gas Tax Fund for 2016.
- The Union of BC Municipalities administers the Federal Gas Tax Fund in British Columbia in partnership with the Government of Canada and the Province of British Columbia.
- Each year, the Government of Canada provides over \$253 million in indexed funding for local
 government infrastructure projects across British Columbia through the federal Gas Tax Fund. The
 funding can be spent on any eligible project the community prioritizes across a broad range of eligible
 project categories, or it can be pooled with other communities for regional projects, banked for later
 priorities or used to pay for financed projects.
