DELEGATIONS:

Prior to the 1st presentation, and at the request of the Acting Mayor, the CAO read to the meeting a copy of the letter forwarded to the Grand Forks Recreation Commission requested that the pool remain open except for the required two week maintenance shut down in September.

a) Grand Forks Aquatic Centre User Groups

On behalf of the Grand Forks Aquatic Centre User Groups, Cora Evers-Ludwar spoke to Council regarding the proposed August closure of the Aquatic Centre.

Betty Brussell advised Council of her regular attendance at the Grand Forks Aquatic Centre and her gold medals won at competitions.

Jane Grey stated the benefits she receives from being able to regularly swim in the Grand Forks Aquatic Centre. Requested that Council do everything possible to keep the pool open.

A letter from Katie Jepsen was read. Ms. Jepsen runs a daycare centre in Grand Forks. Her letter stated her daycare patrons use the pool every Friday morning and her daycare children take swimming lessons. The letter stated Ms. Jepsen's request that the pool be open for longer hours especially when kids are out of school.

Becky Dean on behalf of children and youth of the pool., stated that summer months are the best months to use the pool, as it provides recreation, swim lessons, including kayaking, scuba diving, and "Nights Alive" youth evenings. She encouraged Council to keep the facility open.

Pam Davies stated that the original planners of the Aquatic Centre recognized the benefits for seniors. She expressed her gratitude to the pool staff for their efforts towards her therapy, following surgery. She stated that the need for the pool for therapy use will only increase as the senior use increases.

It was stated that persons with development disabilities use the pool on a regular basis and that this is a vital benefit to these people.

Kirsty Jacobsen – expressed her concern on the health care of the residents should the pool close. She stated that continuous access to the pool, will provide health benefits to many people and questioned the judgement in closing the pool even temporarily. She stated that the pool should be upgraded and maintained and kept open year round.

Amy Enns – spoke on behalf of Real Estate agents in Grand Forks. She advised that part of the sales in Grand Forks are based on the amenities that the community has to offer such as the Grand Forks Aquatic Centre. She further advised that there is currently a boom in real estate, and the loss of the pool would be a real detriment.

Council members stated their intention to keep the pool open. Some members of Council provided background on the recreation funding for all recreational facilities.

b) Friends of the Grand Forks Aquatic Centre

On behalf of the Friends of the Grand Forks Aquatic Centre, John Mackey addressed Council relative to the proposed closure of the Aquatic Centre in August. He stated that the quality of life in Grand Forks is being reduced. He stated that numerous positive letters have been received by Council, indicating that the residents want the facility open. He advised that when the pool first opened, it was open to the public 86 hours per week and is now open less than 50 hours per week. Council members advised that there is an intention to go to referendum in the fall. Mr. Mackey stated he does not have the authority to run the facility without the funding in place. Some discussion continued as to operating the facility in a deficit position.

Mr. Mackey ended his comments by stating that an immediate decision about the pool staying open, needs to be made. The Acting Mayor stated that a decision cannot be made this evening, however Council will guarantee that the pool will stay open in August. He further suggested that an answer will be coming forthcoming this week.

The meeting was recessed at 7:24 p.m. and reconvened at 7:40 p.m.
