<u>Councillor Krog – UBCM report:</u> Councillor Krog reported that he had attended the UBCM and came back with a great deal of good information on a variety of matters. He reported that the City's resolution regarding Alternative Justice and Water boards were endorsed. He advised that, while at the UBCM convention he also participated in Association of Kootenay Boundary Local Governments executive meeting. Councillor Krog said that he is heartened by some of the provincial funding announcements such as traffic revenues be given to municipalities and the doubling of provincial tourism funding.

RDKB Representative - Councillor Krog reported that the Board of the RDKB gave three readings to the Aquatic Centre referendum bylaw. He further reported that Directors for Areas C, D, and E gave grants in aid for the Phoenix Ski Hill in the amounts of \$3,000 each from C and D and \$5,000 from Area E. With regard to waste management, Councillor Krog advised that the RDKB is looking at the potential for regional financing for bluebox recycling, rather than the current system whereby the municipality pays the full amount.

prospect of paying for policing when reaching population 5,000. He said that many communities reported starting a reserve fund to build up to paying policing costs. Councillor Shkrabuik reported on a tour he had taken of a subdivision that had been devastated by fire in the summer of 2003. He remarked that the rate of recovery was incredible with the entire subdivision having been rebuilt, including sidewalks and landscaping.

<u>Councillor Gordon – UBCM report -</u> Councillor Gordon reported that members of Council met with the Honourable Murray Coell, Minister of Community, Aboriginal and Women's Services to request reconsideration of the City's funding application for the west end reservoir. She stated that Mr. Coell advised that occasionally communities that were awarded infrastructure funds couldn't come up with the matching portion and so that money was returned to the province and so, perhaps further money could be available that way. Councillor Gordon reported on a meeting with the Honourable Geoff Plant, Attorney General, stating that they had discussed the cost and extent of vandalism. She said that the Minister had referred Council to the Parental Responsibility Act as another avenue in which to combat vandalism.

Councillor Gordon said that she toured the Kelowna Airport and had a briefing on their expansion. She reported on Council's meeting with the Honourable Mike DeJong and their discussion regarding forestry and the City's proposed International Emergency Operations Base. She said that Council had also met with representatives of the Provincial Emergency Program to discuss the Emergency Operations Base proposal and BC Ambulance Service personnel to discuss night air medivacs from the Grand Forks Airport. Councillor Gordon reported that Council was also able to secure a last minute meeting with the Honourable Shirley Bond, Minister of Advanced Education, to discuss advanced educational opportunities in Grand Forks

On other matters, Councillor Gordon said the final draft of the Cascade Power Project proposal report is expected by the end of the month and that it will then go to three different cabinet ministers for approval.
