### Councillor Gordon:

Councillor Gordon reported on the following activities:

- Reported on her discussions with public health as to the matter of the outbreak of whooping cough in Grand Forks.
- Reported on her efforts to follow up on Community Health Promotion funding through UBCM. Stated she has made Interior Health aware of the funding and is hopeful for a meeting with local officials to come up with eligible projects.
