- 4. Council may not make any decisions at this meeting and if Council wishes, the item would be referred to Staff for follow-up and recommendation for Council to consider at a regular meeting of Council.

Inquired as to the status of the Community Centre project. The City Manager, at the request of the Mayor, advised that the City has sent letters to architects inviting proposals for the design of the new community centre.
