# a) City Clerk's Report – Regional District of Kootenay Boundary Presentation on regional district services

Welcomed to the meeting at this time was Mr. John MacLean, Chief Administrative Officer for the Regional District of Kootenay Boundary. Mr. MacLean advised that the purpose of his presentation was to provide information on what the regional district can and cannot do, and to further open up communication between the regional district and member municipalities. Mr. MacLean's presentation focused on the following points.

- The Regional District of Kootenay Boundary provides a professional level of governance that is accountable and responsible to the needs of the regional community.
- The Regional District of Kootenay Boundary was incorporated in 1966, and derives its authority from the existing local government act and limited sections of the community charter.
- Region wide services he advised that all taxpayers contribute equally, and benefit equally, from participation in regional wide services which were established either by letters patent or service establishing bylaws. He advised that service bylaws are very specific. Region wide services include general government administration services, building inspection services for all electoral areas, and for member municipalities by contract, environmental planning for electoral areas and for municipalities by contract. Region wide services also include recycling services, 9-1-1 services, in partnership with the Regional District of Central Kootenay, and emergency preparedness.
- Services provided in partnership with the City of Grand Forks and electoral areas, include the arena, aquatic centre, mosquito control, library services, boundary museum, and the community centre.
- Discussed 5 year financial plan
- Discussed assessments comparatively.
- Discussed the Regional District of Kootenay Boundary Budget which is approximately \$29,000,000, up \$1.5 million from last year.
