She concluded by advising that the library is currently working on programming for the fall however, it will be predicated on receiving adequate funding.

- Suggested more public education needed prior to the adoption of the bylaw
- Discussed enforcement of the bylaw, stating that the first part is education. Considered the option of enforcing the bylaw on citizen complaint, similar to unsightly premises, and the process involving warning letters with a request to cease, and should the offense not be resolved, the party would be given a show cause hearing in front of Council.
- John Vere, Wood Stove Exchange Coordinator, at the request of the Committee, commented on the draft bylaw, stating that in his opinion the intent of the bylaw is education.

- Sylvia Treptow of Grand Forks, made comment on the matter of medical marijuana, suggesting there is already access to safe medical marijuana, so there is no need for the City of Grand Forks to be involved in this issue. She distributed copies of her comments.
- Ann Higgs resident of Grand Forks, spoke of her experience with people using medical marijuana, stating that the process is complicated.
- Arlena Wallace, of 1665 68th Avenue, applauded the discussion of the medical marijuana issue.
- <u>David Janzen of Grand Forks</u>, stated that he has support from the Grand Forks Senior Citizens Branch No. 68 to serve on the medical marijuana task force.
- Ann Wallace a resident for three years spoke in favour of the medical marijuana issue for pain reduction.
- <u>Barry Brandow</u> provided input as to an issue coming up on the Regular Meeting agenda, being the proposed Council support of an application to the Ministry of Environment by the Mehmal Ranch to restore Lost Lake. Mr. Brandow provided suggestions as to the application, suggesting that this is a positive first step.
