d) City Clerk's Report – Noise Complaint 7581 3<sup>rd</sup> Street

The Mayor invited those in the gallery that are involved in this issue to come forward and provide input to Council at this time.

## Erna Gobbett – lives on 4<sup>th</sup> Street:

Mrs. Gobbett expressed her concerns as to the loud noise in the neighborhood, stating her opinion that this noise is not appropriate inasmuch as it can be heard on the next street inside her house. She advised that the band practices 2-3 hours at a time.

## Zak Waterlow – lives at 7581 3<sup>rd</sup> Street

Mr. Waterlow stated that he had not had contact with his neighbors on the matter of noise from his band practicing until recently. He advised that his band practices no more than 5 hours per week at 2 or 3 times different times, and not on a daily or full time basis. He advised that his acoustic drums are not amplified, and that other instruments are amplified to match the drums. He stated that the band is trying to be minimal and not excessive. He stated that both of his adjacent neighbors work night shifts and have stated that they are not bothered by the band, and in fact, support the band practices. He advised Council that he personally canvassed his neighbors and the majority support his band playing.

Councillor Thompson read into the record, comments from <u>Laverne Simpson of 7560 4<sup>th</sup> Street</u>, who advised that she wished to withdraw her name from the petition against the band playing at 7581 3<sup>rd</sup> Street. A copy of the email comments are attached to these minutes.

#### Shawn Fitzpatrick -

He advised Council that the noise disturbance has been going on for quite some time & that people did not come forward for a number of months. He stated that he and his family, and Mrs. Gobbett,

are not the only neighbors that do not appreciate the loud music. He suggested that music is in the "ears of the beholder". He requested that Council enforce the Noise Bylaw. He stated that the noise was a disturbance in the winter; however, it is more of an issue during the summer, as people wish to enjoy their backyards. He advised Council that one of his concerns in agreeing to practice schedules is the fact that there are neighborhood people who have not stepped forward, and if he were to agree to a practice time, it may not be acceptable to these other people in the neighborhood.
