- Inquired as to the Heritage Courthouse Steps and any contemplated repair to this heritage building. City Manager advised that Staff will bring forward a report to Council on the options available for repair including the costs involved in these options.
- Inquired as to the RINC grant status. The City Manager advised that the grant only covers one third of the required funding for the project and that the City will need to identify the other two thirds of the required funding prior to the project proceeding. He stated that if all the funding is not available then the project cannot proceed.
- Congratulated the Black Train Bridge Society on the installation of the galvanized handrail on the Black Train Bridge.
- Congratulated the Boundary Women's Centre on this past weekend's performance.
- Advised that the Rivers' Edge Theater Group will have an upcoming performance

Councillor Thompson:

Councillor Thompson reported on the following items:

- Reported on her attendance at the last Phoenix Foundation Meeting, launching their Vital Signs Report. She advised that the event was well attended at the Art Gallery in conjunction with the Phoenix Foundation's Annual General Meeting. She stated that Cathy Manson and Bill Strookoff were awarded lifetime memberships in the Foundation. It was noted that the Phoenix Foundation was unable to give grants in 2009 due to the decline in funds, however it was announced that grants will be considered in 2010 for specific areas.
- Reported on an informal meeting of the boards of the Boundary Museum and the Grand Forks Art Gallery at Fructova School wherein the groups discussed how the groups can work together in the future.
- Reported that the Boundary Museum Society has made application for funding under the Job Creation Program.

Councillor Wyers:

Councillor Wyers reported on the following items:

- Reported on her attendance at the launch of the Vital Signs Project on October 6th.
- Reported on her attendance on a tour of the Gilpin Grasslands, which included the viewing of Lost Lake and the Boothman Slough. She added that the tour was joined by MLA John Slater.

- Announced that this is Small Business Week, October 18 24, 2009.

The Phoenix Foundation launched their Vital Signs report on October 6th. This was a very well attended event held in the Art Gallery in conjunction with the Phoenix Foundation's Annual General Meeting. Cathy Manson and Bill Strookoff were awarded lifetime memberships in the Foundation as a token of the Board's appreciation of their 12 years of dedicated service to this organization. Committee chairs presented reports, and of note was the inability of the Phoenix Foundation to give grants in 2009 due to the decline in the funds. However, it was announced that grants will be considered in 2010 for specific areas, and that further information regarding the criteria will be announced early in the new year.

On October 7th, an informal meeting of the Boards of the Grand Forks Art Gallery and the Boundary Museum was held at Fructova School. We discussed ways in which we can work together, including encouraging visitors to go on a "circle tour" of all historic venues in our area.

The Boundary Museum Society has made application for funding under the Job Creation Program. If successful in the application, it is hoped that employees will be hired to do, among other things, some ground work, painting and minor repair work to display areas, assisting in the setting up of displays, and marketing. The Board anticipates the grand opening of the Musem in the spring.
