Jenny Coleshill made a presentation to Council with regard to a proposed Stewardship Agreement between the City of Grand Forks and the Granby Wilderness Society to help protect wildlife, trees and other critical habitat features for wildlife. She advised that this proposal stems from a Conservation Action Plan which focused on creating projects and actions for species at risk. She went on to add that the Lewis Woodpecker for example, is endangered due to a loss of habitat in mostly hazardous trees, ponderosa pines and cottonwoods, in urban areas for projects such as trail construction. She stated that although safety is always a primary concern, there are ways that hazardous trees can be addressed, using best management practices that preserves natural habitat for birds. Ms Coleshill advised that she is working on an education campaign aimed at city workers, land developers, and contractors, adding that trail placement is critical for endangered species. She concluded by requesting that Council consider the Stewardship Agreement.
